### HOISTING:

Power and Sailboats with Mast Down:

29' or under	\$4.00/ft. (\$116.00 Min.)
30' to 39'	\$6.35/ft.
40' and up	\$7.85/ft.

Sailboats with Mast Up:

29' or under	\$4.50/ft (\$130.50 min)
30' to 39'	\$7.00/ft.
40' and up	\$8.50/ft.

(\$25.00 prep charge for rear stay)

**Please Note:** The above prices are one-way. Spring launch is an additional charge. There is an additional 50¢/ft.

**SURCHARGE FOR NON-STORAGE CUSTOMERS.**

There is an additional \$50.00 charge for using strap covers during hoisting.

### NOTES:

1. Winter storage rates will apply until April 15<sup>th</sup>.
2. Catawba Moorings guarantees winterizations only if Catawba Moorings re-commissions items.
3. **Catawba Moorings will not be held responsible for heads that are not pumped out. CMI will not pump out heads during Haul Out. The last day for pump outs at our Gas Dock is October 31<sup>st</sup>.**
4. Hand scrubbing unpainted bottoms will be done thru October 15<sup>th</sup> only. If hauled out after Oct. 15<sup>th</sup>, bottom will be pressured scrubbed only.
5. Catawba Moorings will have a charge to flush and fill water system in the Spring.
6. Drain and upgrade closed cooling to -34° \$138.00 minimum per engine.
7. Inside Heated Storage includes haul out in the Fall, launch in the Spring, fogging for gas engines and draining of water system. It does not include bottom scrubbing or shoring.
8. **There is an additional charge of \$200.00 for boats on trailers being stored in the Inside Cold and/or Heated Storage.**
9. **Calculations are made rounding up to the next foot.**
10. We reserve the right to remove canvas and anchors to store boats in the inside cold and inside heated buildings. For boats in buildings, tarps cannot be installed until Nov. 15<sup>th</sup> and must be removed by April 1<sup>st</sup>.
11. If we need to remove bikes, chairs, dinghies, etc., there will be a labor rate of \$138.00 per hour.
12. "For Sale" signs are prohibited on all boats other than Catawba Moorings Brokerage Boats.
13. Outside contractors must be approved by management and will be subject to 15% surcharge.
14. **All boats, on our grounds, inside or outside, cannot be plugged into electric if unattended or overnight.**
